## **Old Business**

- I. **July 4-proceedures discussion**-Two Rivers Health Dept. joined the call Connor posed the question as to whether or not we could host an event or if we would be better off to set them off, but not allow the public to attend on the grounds. Regardless of whether we allow the public to attend on site or now, we will still need to complete the full 38-page plan. The plan then would require approval from Two Rivers and the City. Nickola expressed concern that it would require a large amount of preparation and volunteer help, in addition to the time needed to complete the form and necessary approvals. Marcy agreed that the documentation and approvals needed even if we don't let people on the grounds wasn't worth the time and effort. Marcy moved that we postpone to next year and not host fireworks at all in 2020. Brett seconded. All voted in favor.
- II. Updates on Christmas City Car Show Based on DHM, car show can't go forward without the same report approval process. They can, however, host a parade with no crowd. They are planning a cruise night in the community. Last time a cruise night was proposed, Kathi got approval from Matt via email. She will reach out in the same way to make sure the City was OK with it. It will be scheduled for June 21 (Father's Day).
- III. City Wide Garage Sale it was decided to postpone until the July DHM information comes out.

Sally Jurgensmier was contacted about doing a sculpture and she is interested. Kathi found a grant that would pay for it if we proceed. It was decided that she will move forward.

## **Business Meeting:**

*Approval of May Financial Report* – Brett inquired if our income mostly is from dues or from events and how all the cancelations impacted our bottom line.
