Minden Opera House Renter Release and Waiver of Liability Form

The Release and Waiver of Liability ("the release") executed on the _____ day of _____,

Now therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

The Renter desires to conduct activities at MOH not related to the regular operations of MOH. Renter understands that he/she is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of services provided while at MOH.

Waiver and Release: I, the renter, for myself and my heirs, executors, administrators and assigns, hereby release, waive, discharge, and hold harmless, MOH and its successors, assigns, libraries, directors, officers, employees and agents from any and all liability, claim and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to MOH I understand and acknowledge that this release discharges MOH from any liability or claim that I may have against MOH with respect to bodily injury, personal injury, illness, death, property damage, or any other claim that may result from the services I provide to MOH or occurring while I am providing services.

Insurance: Further, I understand that MOH does not assume any responsibility or obligation to provide me with financial or other assistance, including but not limited to medical, health, workers compensation, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of MOH beyond what may be offered freely by MOH in the event of injury or medical expenses incurred by me.

Medical treatment: I hereby release and forever discharge MOH from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with any emergency during my tenure as a renter with MOH.

Assumption of Risk: I understand that the services I provide to MOH may include activities that may be hazardous. As a renter, I hereby expressly assume risk of injury or harm from these activities and release MOH from all liability.

Other: As a renter, I expressly agree that this release is intended to be broad and inclusive as permitted by the laws of the State of Nebraska and that is Release shall be governed by and interpreted in accordance with the laws of the State of Nebraska. I agree that in the event that any clauses or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
